Dear MR. OGUNGBADE MOHAMMED AYOMIDE,

SUSPENSION PENDING INVESTIGATION

This letter serves as formal notification of your indefinite suspension from the position of President of the National Association of Ikire Students (NAIS) National Headquarters, effective immediately. This decision has been made in light of serious allegations of misconduct brought to our attention, necessitating a thorough and impartial investigation.

The specific allegations against you are detailed below:

1. ABUSE OF POWER (UNAUTHORIZED CHANGE AND ENFORCEMENT OF ANNUAL DUES):

You unilaterally increased the annual dues without adhering to the constitutionally mandated process for review by the Central Executive Council (CEC) or ratification by the Institution Representative Council (IRC). Additionally, you enforced the increased dues without the required approval, despite this matter being discussed in Congress.

This action violates Article 16, Section A {Financial Matters, Patrons, Patronesses and Advisers (SOURCES OF INCOME)}, Sub-section 01 of the NAIS constitution, which mandates:

"There shall be payment of an annual due of #200 by all registered members of the association. However, this is subject to review by the CEC. Such review is subject to the approval and ratification of the IRC."

2. UNCONSTITUTIONAL FORMATION OF THE ELECTORAL BODY:

Traditionally, NAISEC is constituted during the Ileya Congress held at the NAIS Secretariat. However, the president failed to convene the Congress at the secretariat for this purpose. Additionally, nominees for NAISEC positions were not presented to the IRC for ratification, as required by the constitution.

The above action contradicts Article 15, Section A (Congress), Sub-section 04 and 05 of the NAIS Constitution, which states:

04. "All congresses shall hold at NAIS Secretariat."

05. "There shall only be a change of venue for security sake."

Moreover, it violates Article 14, Section B (Power of IRC), Sub-section 15, which states:

"The IRC shall look into and ratify within time frame any appointment and resolutions made by the CEC."

Additionally, it contradicts Article 15, Section C (Motions and Observations), Sub-sections 01-04, which state:

01. "There shall be only one motion on the floor."

02. "Ratification of adopted resolution shall be approved by the simple majority of members present at the congress."

03. "All motions shall be moved and seconded before such a motion is adopted or countered."

04. "The president shall ask for counter-motion before adoption."

By failing to uphold these constitutional provisions, the President compromised the transparency and procedural integrity required in forming the electoral body.

3. PUBLIC VERBAL ATTACK AND USE OF PROFANE LANGUAGE AGAINST THE DEPUTY SPEAKER [HON. GANIYU IBRAHIM OPEYEMI]:

During online discussion on the NAIS Official WhatsApp Platform, the President verbally attacked and assaulted the Deputy Speaker using the profane phrases "Ayé ẹ̀ dè máà bajẹ̀ nì" and "Ode ni se orire." In English, this translates to "Your life will spoil, and you won't succeed." This behaviour was highly unprofessional and created a hostile environment.

The above action contradicts Article 20, Section A (Code of Conduct), Sub-section 06 of Nais constitution that states; "Under no circumstance shall any CEC member or Congress engage in fighting, the use of offensive language, assault, or any other related misconduct. Such allegation shall be reported to the IRC and shall attract strict disciplinary measures."

The President's use of profane language during this incident contradicted the code of conduct, which explicitly prohibits offensive language and requires professionalism from all members.

4. CONTROL OF INFORMATION AND MISINFORMATION; DISRESPECT FOR THE HOUSE:

You are accused of adding unknown or cloned numbers to the NAIS official platform, which were allegedly used to intimidate members who expressed dissent. Additionally, you frequently deleted official resolutions from the platform, hindering communication and obstructing the IRC's ability to track progress or discuss resolutions.

This behavior violates:

- Article 14, Section B (Powers and Function of the IRC), Sub-section 01, which states:

"The IRC shall discuss the progress and activities of the association's committees, and make recommendations to the CEC and Congress."

- Article 20, Section A (Code of Conduct), Sub-section 09, which states: "No officer shall breach the trust and confidence reposed in him/her."

By fostering intimidation, tampering with official communication, and deleting resolutions, you breached the constitutional provisions requiring transparency, trust, and respect for the IRC's duties.

SUSPENSION DETAILS:

In accordance with the Association's constitution and disciplinary procedures, MR. OGUNGBADE MOHAMMED AYOMIDE is hereby placed under indefinite suspension from all official duties and privileges associated with your role as President. This suspension is intended to allow an unbiased investigation into these allegations.

Additionally, ADEGOKE USMAN, the FINANCIAL SECRETARY and MUYIDEEN SHAKIRU ADEWALE, the PUBLIC RELATIONS OFFICER 1 (PRO 1) who are alleged to have aided in these unconstitutional acts, are also placed under indefinite suspension.

SUSPENSION AND NEXT STEPS :

To allow for an impartial investigation into these allegations, you are hereby suspended from all duties and responsibilities associated with your position as president. This suspension is in line with the disciplinary procedures outlined in the NAIS constitution and will remain in effect until the conclusion of the investigation.

DURING YOUR SUSPENSION:

- 1. You are prohibited from performing any official duties or representing the association in any capacity.**
- 2. You are expected to fully cooperate with the investigation process.**
- 3. Any noncompliance or further misconduct may result in additional disciplinary action**

An independent inquiry will be conducted, and you will have the opportunity to present your defense. Further details regarding the investigation process will be provided in due course.

We urge you to take this matter seriously and to respect the organization's constitution and procedures.

In conclusion, Article 9, Section C {Duties of Officers - (The Vice President)}, Sub-section 04 of the constitution clearly states: "The Vice President shall be the President should the incumbent President be impeached, suspended, or resigns."

Therefore, in line with this provision, the Vice President is urged to immediately take over the responsibilities and duties of the President to ensure continuity and effective leadership.
